**Pastoral/Practical Information for Preparations for Mass**

*It would be helpful for those who are preparing this Mass to review the diocesan publication "We Have Come to Worship Him" which addresses many of the liturgical issues and questions that frequently arise during such preparations.*

*(Copies are available through the diocesan Office of Liturgy)*

Here are some highlights to address some of the more frequently asked questions:

**DUPLICATION OF MINISTRY:**

- ☒ No single liturgical minister should serve more than one liturgical role at any given liturgy. (e.g. a lector should not also be an Extraordinary Minister of Holy Communion, the musician also not be a reader, etc.)

**INTRODUCTION:**

- ☒ Prior to the Mass, a designated person may wish to address the assembly. Otherwise, Bishop Cistone will incorporate the reason for his presence into his presidential greeting.

**PSALM:**

- ☒ The psalm should be sung from the Ambo.
- ☒ The psalm should be based on/ and/or adapted for an actual psalm text.
- ☒ The best resource is the "Grail" translations/text of the psalms.
- ☒ It is permissible to sing a "Seasonal Psalm."

**EXTRAORDINARY MINISTERS OF HOLY COMMUNION**

- ☒ It is normative that an Extraordinary Minister of Holy Communion be a fully initiated Roman Catholic who is at least 16 years of age.
- ☒ They should be properly trained and attired for the ministry.

**COMMUNION HYMN**

- ☒ The Communion Hymn begins while the priest-celebrant is receiving the Blessed Sacrament.
- ☒ The proper posture for each person in the assembly is to remain standing until he/she has received Holy Communion; then they may either remaining standing, kneel or sit.
- ☒ The Communion Hymn should reflect a "Eucharistic" theme and be Christ-focused. It is neither the time for a choir motet nor a solo selection. It is a congregational song, preferably a refrain with cantor and/or choir singing verses.
- ☒ There is need for only one (1) Communion Hymn; planning should incorporate a provision for all liturgical musicians to receive Holy Communion without interrupting the integrity and flow of the procession and music. Musicians, cantors, servers, or any other Liturgical ministers should not be receiving Holy Communion at the same time as the Extraordinary Ministers of Holy Communion.
- ☒ There is no mention of a "Communion Meditation" in the GIRM. However, after a period of silence it is permissible for a hymn of thanksgiving to be sung by the entire assembly (#88 & 164). When using a hymn of thanksgiving, it may not be necessary to also sing a Recessional Hymn. The Recessional may be an instrumental selection.

**ANNOUNCEMENTS**

- ☒ The Ambo is reserved for the proclamation of the Word of God. The Altar is reserved for the celebration of Mass. As such, announcements should never be made from either the Ambo or the Altar. Rather, it is suggested they be made from either the presider's chair or the cantor stand.
