

Archbishop Lori and Cardinal Dolan respond to Senate Rejection of Extreme Abortion on Demand Bill

After the misnamed Women's Health Protection Act failed to advance in the Senate early this week, Archbishop Lori and Cardinal Dolan issued a <u>statement</u> saying, "We must respect and support mothers, their unborn children, and the consciences of all Americans. Passing H.R. 3755 would have led to the loss of millions of unborn lives and left countless women to suffer from the physical and emotional trauma of abortion. Rather than providing comprehensive material and social support for a challenging pregnancy, H.R. 3755 fails women and young girls in need by instead offering a free abortion as the 'solution' to their difficulty. Women deserve better than this. We implore Congress to promote policies that recognize the value and human dignity of both mother and child." U.S. Bishops' President Echoes Pope Francis' Call for Prayer and Fasting for Ukraine

Archbishop José H. Gomez of Los Angeles, president of the U.S. Conference of Catholic Bishops issued this <u>statement</u> on Ukraine: "On behalf of my brother bishops, I echo the Holy Father's call for prayer and fasting to end the war in Ukraine. In times of trouble, we call on the tender mercy of God ... to guide our feet to the way of peace (Lk 1:78-79). May our prayers, joined with those of people around the world, help guide those waging war to end the meaningless suffering and restore peace. Our Lady, Queen of Peace, pray for us." Bishop David J. Malloy of Rockford, chairman of the U.S. Conference of Catholic Bishops' Committee on International Justice and Peace, said in an earlier <u>statement</u>: "In this time of fear and uncertainty, we stand in solidarity with the Church in Ukraine and offer our support. We call on all the faithful and people of good will to pray for the people of Ukraine."

Bishops support including the Afghan Adjustment Act and Pregnant Workers Fairness Act in budget agreement

As negotiations on an omnibus package continue, the USCCB urges Congress to consider including the bipartisan Pregnant Workers Fairness Act, and Afghan Adjustment Act in any agreement. In their letter of support for the Pregnant Workers Fairness Act, three bishop chairmen wrote, "The Catholic bishops of the United States have repeatedly called for circumstances of employment that better support family life, especially in the challenges associated with having children.." The bishops are also urging Congress to provide a pathway for Afghan parolees to pursue lawful permanent resident status. Background on Afghan Adjustment Act.

Did You Know?



Each year on Ash Wednesday is the U.S. Conference of Catholic Bishops' (USCCB) Collection for Central and Eastern Europe. In 2021, gifts to the collection provided more than \$6.4 million for 348 grants to support the Church in Central and Eastern Europe. For example, in Poland, where more than 1 million people have fled the ongoing war in Ukraine, the Jesuits of Southern Poland and Ukraine Mission established DEON, UA, a Ukrainian language digital platform offering secular and Catholic news and discussion forums to help Ukrainian immigrants stay informed and build relationships.
